- 2 The Kerala Public Service Commission shall have the power to cancel the advice for appointment of any candidate to the above post, if it is subsequently found that such advise was made under some mistake. On such cancellation the appointing authority shall terminate the service of candidate, provided that, the cancellation of advice for appointment by the Commission and subsequent

termination of service of the candidate by the appointing authority shall be made within the period of probation or 240 days from the date of joining duty whichever is earlier.

5. Method of appointment : Direct Recruitment (Candidates belonging to Ezhava/ Thiyya/ Billava and Latin Catholic/ Anglo Indian Communities only)

Note : Application submitted by Candidates other than from Ezhava/ Thiyya/ Billava and Latin Catholic/ Anglo Indian Communities will be summarily rejected. No rejection Memo will be issued to them individually.

6. Age limit : 18-39; Only candidates born between 02.01.1982 and 01.01.2003 (both dates included) are eligible to apply for this post. (Including the relaxation as per Para 2(i) of the general condition) (For details regarding age relaxations, please see Para 2 [except 2(i)] of part II General Conditions)

7. Qualifications : a) SSLC or Equivalent.

b) Two years Experience in the Camera section of a Film studio of repute.

Not e: The provisional hands working in the above concern will be given age relaxation to the extent of their provisional service put in subject to a maximum of Five years from the upper age limit provided they are within the prescribed age limit on the date of their first appointment in the above concern. But the regular employees of the concern are not eligible for the above concession for further appointment. The provisional hands should obtain a certificate showing the period of their provisional service in the concern and shall produce the same as and when required by the Commission. It would also be clearly specified in the certificate that they were not working in the regular service of the concern.

Candidates who claim equivalent qualification instead of qualification mentioned in the notification shall produce the relevant Government Order to prove the equivalence at the time of verification, then only such qualification shall be treated as equivalent to the prescribed qualification concerned.
3. In the caste of a candidate is wrongly mentioned in the SSLC book, the candidate should claim their original caste in the application and should produce the community certificate / Non - Creamy layer certificate

issued from the revenue authority concerned along with the Gazette Notification of the same at the time of certificate verification

4. Appropriate disciplinary action as per KPSC Rules of procedure Rule 22 will be taken against those candidates who give confirmation for writing examination by making false claims about qualifications such as education, experience etc. regardless of whether they attend the examination or not.

The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information in their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. **Candidates are advised to keep a printout or soft**

copy of the online application for future reference. Candidates can take the printout of the application by clicking on the link 'My applications' in their profile. All correspondences with the Commission, regarding the application should be accompanied with the print out of the application. The application will be summarily rejected if non-compliance with the notification is found in due course of processing. Original documents to prove qualification, experience, age, Community etc. have to be produced as and when called for.

b. If a Written/OMR/Online Test is conducted as part of this selection, Candidates who possess requisite qualifications as per para 7 above only shall submit a confirmation for writing the examination through their One Time Registration profiles.
